**Updated Notice on Requirements  
For Travelling to Nepal**

Following the decision taken by the Government of Nepal on 21 June 2021, all passengers (Nepali and Foreign nationals) travelling into Nepal from France, Portugal, Andorra and Monaco are required to follow compulsory the guidelines mentioned hereunder with immediate effect:

1. All passengers must have medical certificate with a negative RT-PCR or equivalent testing (Gene Xpert/True NAAT) report with photo identification and Barcode/QR code issued by registered COVID-19 labs of respective countries within 72 hours from the swab collection time to the check-in time at the airport. Children below 5 years are exempted from this requirement.
2. All passengers must carry the printed barcode obtained after filling up ***International Traveler Online Arrival Form*** available at the website of Covid-19 Crisis Management Center, Nepal (**[www.ccmc.gov.np](http://www.ccmc.gov.np)**)
3. Except the conditions stated in point no. 4 below, all passengers are subject to furnish the evidence of hotel booking for 7 days for quarantine at their own cost at the hotels listed by Nepal Tourism Board ([www.welcomenepal.com](http://www.welcomenepal.com)) or CCMC ([www.ccmc.gov.np](http://www.ccmc.gov.np)). Passengers staying at the hotel during quarantine are required to take a PCR test on the 7th day of their arrival. If the result is negative, they will be allowed to continue the quarantine at home for 4 more days under the supervision of the local authority.
4. Passengers who fulfil the condition mentioned in paragraph (a) below or who are arriving in Nepal for the reasons mentioned in paragraph (b), (c) and (d) below and carrying supporting documents shall be allowed to stay at home quarantine for ten days upon arrival if their Antigen test for Covid-19 is negative:
  - a) Passengers having a complete Covid-19 vaccination certificate.
  - b) Travelling for emergency reasons such as funeral/mourning the death of the close relative with the recommendation of the concerned local authorities or CCMC.

- c) Sick people as well as their care givers (maximum 2 persons), senior citizens aged 70 years and above, children below 5 years and their parents, chronic patients, and differently able persons certified by hospitals and with the recommendation of the local authority.
  - d) Government employees, security personnel, diplomats and their family members returning to Nepal, individuals/volunteers involved in rescue mission of the victims of Human Trafficking and Nepalis stranded abroad who possess the recommendation of their employer or agencies concerned.
5. The passengers mentioned in Paragraph (a), (b), (c) and (d) above are required to have a compulsory RT-PCR test on the 11th day of their arrival in Nepal.
